GENERAL CONDITIONS

Pet Vacations, Inc., (Pet Vacations) acknowledges receipt of the above named pet (The Pet), and agrees to provide through a qualified Pet Vacations caretaker, reasonable and appropriate care while the pet is under its care. Pet Vacations shall reasonably try to accommodate any specific instructions given by owner. Owner waives all claims of any type and nature against Pet Vacations and/or its caretaker for damages or injuries occurring because of any pre-existing physical condition of the pet.

The liability of Pet Vacations and/or its caretakers to owner is limited to the sum of the value of the pet with a minimum of two hundred dollars (\$200.00) for each cat or dog, and seventy five dollars (\$75.00) for each other species of pet and a maximum of five thousand dollars (\$5000) per pet boarded in the event of loss or death to the pet resulting from our care.

Pet Vacations and/or its caretaker will make every reasonable effort to prevent the transfer of fleas. But due to the unpredictable nature of pets, Pet Vacations and/or caretaker cannot guarantee that the pet will be returned without fleas.

Owner agrees that Pet Vacations and/or its caretaker are not responsible for the actions of the pet, or for any damages or injuries caused by the pet. Owner shall indemnify and hold Pet Vacations and/or its caretaker harmless from any action, claim or lawsuit, including its attorney's fees, connected with damages or injuries to third persons and pets caused by the pet. Owner assumes all property damage and/or personal injury caused by the pet.

If the pet becomes seriously ill, Pet Vacations and/or its caretaker shall notify owner or owner's designate as soon as is reasonably possible, to ascertain what treatment is desired. If Pet Vacations and/or its caretaker is unable to reach owner or owner's designate, and in the opinion of Pet Vacations and/or its caretaker the state of the pet's health requires immediate medical attention, Pet Vacations and/or its caretaker is authorized to secure a veterinarian, preferably the owner's choice, to administer the appropriate medical treatment. Any and all of the pet's health related expenses (including transportation fees) shall be the sole responsibility of owner unless Pet Vacations and/or its caretaker attributes the injury to their care in which case Pet Vacations and its caretaker are fully liable for costs incurred in immediate treatment. Owner agrees to hold Pet Vacations and/or its caretaker harmless from any action, claim, or suit, including its attorney's fees, brought by third parties connected with medical treatment to the pet for which owner is responsible. Owner represents that all Pet's vaccinations are current, the pet is free from contagious disease and all pertinent information the Pet's health and behavior have been disclosed in "Special Conditions and Information" of this Agreement.

The set up fee and daily rate to be paid by owner to Pet Vacations for the care of the pet shall be due when pet is picked up by owner. This agreement is also valid for any future pet care arrangements for any owner pet.
